Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, March 10-14, 2024, naming Air Conditioning Contractors of America (1520 Belle View Boulevard #5220, Alexandria, VA 22307) as the certificate holder. The following must be named as additional insured: Air Conditioning Contractors of America (ACCA) and Loews Sapphire Falls Resort.

ACCA has requested that Rainprotection serve as their insurance management company. In addition to being able to provide exhibitors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance.
